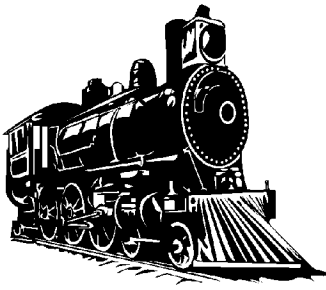


# *15<sup>th</sup> Annual Beasley Bash*

## *Talent Contest Rules and Regulations*

1. All completed entry forms must be received no later than May 7, 2010.
2. All performers will be divided into four age groups: 5-8 years, 9-12 years, 13-16 years, and 17-adult.
3. All acts will be divided into age groups regardless of the talent being performed.
4. No act will exceed 4 minutes, but must be a minimum of 2 minutes.
5. Any act that is deemed improper or offensive will be pulled from the contest.
6. Judging for each age group will be based on:
  - a. Appearance
  - b. Audience Reaction
  - c. Knowledge of Material
  - d. Presentation
  - e. Talent Ability
7. There will be (3) places awarded in each age category. 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> places will receive a trophy. Everyone who participates will receive a ribbon. There will be a \$50.00 Gift Card awarded to one of the 1<sup>st</sup> place winners as Best of Show based on highest cumulative score.
8. Performance must be performed on stage in order to be judged.
9. Any exceptions to the rules can only be received from the Talent Contest Chairperson.
10. Parental Consent and Release of Liability Forms must be notarized.
11. Judges decisions are final. In case of a tie, the higher talent ability score will be used. If it is the same, the judges will have to decide the winner.
12. On day of contest, all performers must be checked in and in place by the stage at the George Pavilion no later than 1:30 PM. A number will be assigned to be placed on the clothing.
13. Sound equipment will be provided, but each contestant is responsible for supplying his/her labeled musical CD, if necessary.
14. Do your best and have fun!

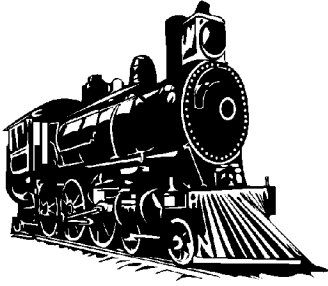
