



# 15<sup>th</sup> Annual Beasley Bash

## Queens / Jr. Miss

### General Qualification & Policy

1. Female Queens contestants must be between 14 and 19 years of age as of May 14, 2010. Jr Miss Contestants must be between 8 and 13 years of age as of May 14, 2010.
2. All contestants must be a single female, never have been married, never had a marriage annulled, never have given birth and never have been convicted of a felony prior to the contest. The contestant must be in good moral character and never have been convicted of any crime, with the exception of Class C traffic offense. If the contestant violates the Controlled Substance Penal Code Act, she will be disqualified from this contest. These rules will remain intact throughout the reign of the Queen / Jr Miss and her runners-up. If any of these infractions occur then the crown and any awards will be forfeited.
3. Contestants are to be in good health. Good health is defined as adequate health to fulfill duties of Beasley Queen / Jr Miss if selected. Each contestant will not hold the Beasley Community Committee, City of Beasley, Beasley Farmers Gin, or any individual or organization associated liable for any accident or injury that may or might occur as a result of the contest or future obligations. A Release Form must be signed and submitted with the entry forms.
4. No contestant can be directly related to or be under the guardianship of any current Beasley Community Committee member.
5. Permission is hereby granted to the Beasley Community Committee to use photographs and information submitted for the contest in news stories or other publicity in advance of the contest. Pictures may be altered for reproduction purposes only.
6. Forms must be completed and turned in by 7:00 p.m., Thursday, March 11, 2010 at the Beasley Fire Station, 214 S. 3<sup>rd</sup> Street, Beasley, Texas 77417 or mailed to: Beasley Community Committee, Attention: Terri Cisneros, P. O. Box 195, Beasley, Texas 77417.
7. Each contestant will be required to sell a minimum of \$500.00 in raffle tickets to be eligible for the contest. Qualifying sales money must be turned in to Lisa Meyer or Terri Cisneros prior to the date of Judge's Interview.

8. Each contestant will be responsible for any shortages in ticket and/or money balance at the end of the contest. A form will be provided to each contestant to keep track of sales and monetary donations.

9. Scoring will be calculated by the point system as follows:

Raffle Ticket Sales..... 50.0 Points  
1 Point for every \$20.00 sold after the first \$500.00 in sales

Interview with Judges. .... 50.0 Point(per Judge)

Appearance..... 30.0 Points  
Personality..... 12.5 Points  
School/Community Involvement..... 12.5 Points

Bonus for Participation..... Up to 60 Points  
**(Contestants will receive 10 points for every mandatory meeting they attend)**

10. Each contestant must attend all meetings and be present at the rehearsal.

11. All raffle ticket money and collection reports must be turned in to Lisa Meyer or Terri Cisneros. Please call a day ahead for turning in money or if more raffle tickets are needed.

12. Deadline for ticket and money turn in is May 14, 2010, 7:00 p.m. at the Beasley Fire Station. **TURN IN AFTER 7:00 p.m. IS GROUNDS FOR DISQUALIFICATION.**

13. All monetary donations will convert to a monetary point conversion system as follows:

All monetary donations will be logged and the **overall** total will be converted to the following point system:

Level 1.....	\$500.00.....	75 Points
Level 2.....	\$750.00.....	85 Points
Level 3.....	\$1,000.00.....	100 Points
Level 4.....	\$1,500.00.....	125 Points
Level 5.....	\$2,000.00.....	150 Points
Level 6.....	\$3,000.00.....	175 Points
Level 7.....	\$4,000.00.....	225 Points
Level 8.....	\$5,000.00.....	275 Points

Any monetary donation less than \$500.00 will be awarded 10 points per \$100.00.

Any monetary donation that falls in-between levels will revert back to the lower level's points (i.e. \$900.00 falls between Levels 2 and 3. Contestant will receive points for Level 2)

\*\*\* Your first \$500.00 monetary donation can be used towards your qualifying tickets sales if you have not qualified for the contest at the time of collection of said donation.

14. The winner must be able to attend 2010 Beasley Community Committee activities and represent the Committee at other events on request throughout the year. She will also be required to attend the 2011 Beasley Bash Queens Coronation to relinquish the title.
15. All contestants and their representatives must conduct themselves in a manner befitting the Beasley Community Committee and the Beasley Bash. Any immoral contact reported could be grounds for disqualification (i.e. unsportsmanlike like behavior toward other contestants and/or Committee members, pregnancy, expulsion from school, etc.)
16. Posters may be used to promote sales but must first be approved by the Queen's Committee Chairperson and/or the Queens Contest Coordinator.
17. In the event the winner is not able to fulfill all obligations, the 1<sup>st</sup> runner up will assume all responsibilities of the Beasley Queen for the current reign.
18. Each contestant will be required to take part in the Beasley Bash Parade on Saturday morning May 15, 2010, prior to coronation. The Queen Coordinator must approve all entries.
19. Contest winners must be able to assist Committee members with the Silent Auction that will be held immediately after Coronation.
20. The Beasley Community Committee reserves the right to make additional rules and regulations as the situations warrant.
21. Decisions of the Beasley Community Committee are *FINAL*.
